# 3<sup>rd</sup> of July Freeland Freedom Fest & Fireworks Wednesday, July 3<sup>rd</sup> – Freeland Park 2025 Vendor Application and Requirements

BOOTH SIZE: 10'x10' or 10'x20' Please note: Carts or trailers must request a 10'x20' booth to accommodate extra footage for tongue and access.

### COST: \$200 for a 10'x10' spot or \$300 for 10'x20'

BOOTH LOCATION: Vendors will be assigned to their booth location on July 3rd

SET-UP FOR TRAILER OR CART: Must be parked in your assigned area by 3:00

SET-UP FOR BOOTHS: You may begin your booth set-up anytime after 10:00am but no later than 3:00pm

#### Vendors Booth Requirements:

- 1. Provide a floor (the pavement) and a roof (a tarp, pop-up canopy)
- 2. Provide your own table and chairs, etc. for your assigned booth area, whatever you'll need.
- 3. Responsibility for all set-up, tear down and clean up of your booth area.
- 4. Your own extension cords, (14 gauge, 12 gauge is better 25' long min) If you have multiple heavy draw appliances, you need to plan to have a separate extension cord for each of those appliances.
- 5. Provide your own water, ice and change. (There is no onsite water.)
- 6. Two parking passes will be assigned to each booth.
- 7. All propane tanks must be secured by a stationary structure or in a crate.
- 8. Any booth with the use of propane must provide a Class K fire extinguisher for your booth. All others using electrical appliances must have a standard fire extinguisher for their booth.
- 9. All signage must be within your booth perimeter.
- 10. Follow all guidelines posted by Island County Health Department for specific types of food service. Please visit their website or call for all requirements, forms and class times. WEBSITE: www.islandcounty.net/health or call 360-240-5554 x 28

Including but not limited to the following:

- A. Hand washing station
- B. Temporary Food Service PermitC. All food, ice and single-service products must be off the ground and away from sources of contamination
- D. At least one booth worker with a current Food-Handlers card must be in the booth at all times
- E. All booths are subject to an inspection from the Island County Health Department

## NOTE: There will be NO vehicles allowed in the park between 3:00 and 11:00 pm (after the crowd disperses after the fireworks).

POWER: Generator power will be available prior to 3:00pm

LIGHTING: 3<sup>rd</sup> of July Freeland Freedom Fest & Fireworks will provide limited lighting of the vendor area

GARBAGE: 3rd of July Freeland Freedom Fest & Fireworks will place garbage cans in the vendor area. These cans will not be specific to each vendor but will be available for vendors as well as patrons, 3rd of July Freeland Freedom Fest & Fireworks will collect garbage in the eating and seating area as needed throughout the event. Vendors will be responsible to remove garbage items/boxes, etc. from their booth area and dispose of them in the collection truck or container on site.

# FOOD SERVICE TIMES: No food shall be sold or served prior to Health Department inspection and receipt of permit

**BOOTH INSPECTION:** The Health Department is scheduled to arrive by 3:00pm

BOOTH TEAR DOWN: There will be no vehicles allowed back into the park for loading up booths until after the fireworks and crowds clear. If you sell out prior to the end of the event, you may tear down and pack up your booth within your booth space.
